SPECIAL COLLECTIONS REPRODUCTION POLICY

Sandusky Library will make an effort to comply with patron requests for photocopies and other reproductions of Special Collections holdings. When possible, photocopies of the requested holding(s) will be made immediately.

Request for photographic reproductions will be decided on a case-by-case basis. Individuals seeking reproduction of Sandusky Library photographs, documents, or drawings for personal, or commercial use will be charged according to the photographic reproduction price schedule listed below. If it is necessary to create a new negative, the patron will be responsible for the cost of negative reproduction. Any and all negatives become the property of Sandusky Library.

Please allow four to six week, from date of approval, for your reproduction order to be completed.

8x10 (or similar size) print: \$10

11x17 (or similar size) print: \$20

Poster size print: \$30

Digital Image (via email or CD): \$10

SCAN TO DISK: If a patron requires an image to be scanned (as for publication purposes) the image can be scanned to a disk or sent via e-mail for a flat fee of \$10 per image. The digital image will bear a Sandusky Library Follett House Museum digital watermark.

Sandusky Library reserves all rights of ownership, expressed and implied, to its photograph, document, and drawing collections. Permission in writing from the Library Director is required before reproduction in publication is undertaken. Failure to credit material cited in publication to Sandusky Library and Follett House Museum Archives will result in forfeiture of the future use of the collection and may result in legal action.

The use of photographs, documents, or drawings owned by Sandusky Library may result in the assessment of one-time use publication fee. A publication fee is defined as a charge incurred for the use of material(s) owned by another in a visually-communicative format. Examples of publication use many include usage in books, graphical websites, or as framed wall hangings.

Reproduction requests for the purpose of publication in any format should contain the following citation: "Sandusky Library Archives Research Center."

Complimentary Copy: The publisher is to provide the Sandusky Library/Follett House Museum with one complete complimentary copy of the publication in which the image is reproduced. In the case of M.A. theses and Ph.D. dissertations, photocopies of the references to the illustration will be acceptable.

To ensure the long-term preservation of and continued access to our collections, patrons are prohibited from taking flash photographs of Special Collections holdings. The use of tripods, camera stands, or other mounting devices is prohibited. The use of scanners is prohibited.

Sandusky Library reserves the right to refuse a request for reproduction if, in the judgment of the Library Director and Administrator, Reference & Museum Services, reproduction would in any way compromise the condition of the original.

NOTICE: WARNING CONCERNING COPYRIGHT RESTRICTIONS

The copyright law of the United States (Title 17, United States Code) governs the making of photocopies or other reproductions of copyrighted material.

Under certain conditions specified in the law, libraries and archives are authorized to furnish a photocopy or other reproduction. One of these specific conditions is that photocopy or reproduction is not to be “used for any purpose other than private study, scholarship, or research.” If a user makes a request for, or later uses, a photocopy or reproduction for purposes in excess of “fair use,” that user may be liable for copyright infringement.

CONDITIONS OF USE

REQUEST FOR REPRODUCTIONS ♦ APPLICATION FOR PERMISSION TO PUBLISH

1. All requests to reproduce photographs from the Sandusky Library’s holdings must be submitted on this application. The applicant agrees to abide by all terms, conditions, and provisions of this agreement.

Permission for reproduction is granted only when this application is countersigned by representative of the Library. Permission for reproductions limited to the applicant and is not-transferable.

Permission for reproduction is granted only for the expressed purpose described in this application. This permission is non-exclusive; the Library reserves the right to reproduce the image and to allow others to reproduce the image.

Any subsequent use (including subsequent editions, paperback editions, foreign language editions, etc.) constitutes reuse and must be applied for in writing to the Library. Any change in use from the stated on the application requires permission of the Library. An additional fee may be charged for reuse or change in use.

In the event the applicant engages in unauthorized reproduction of the materials, the applicant agrees to pay the Library a sum equal to three times the normal handling fee for each unauthorized use. The applicant also agrees to surrender the copy print to the Library.

2. The Sandusky Library reserves the right to refuse reproduction of its holdings and impose such conditions as it may deem advisable in its sole and absolute discretion to be in the best interests of the Library. The Library reserves the right to refuse any order for reproductions which it feels might damage the original. The decision to allow reproduction of the Library’s holdings rest solely with the Library.

3. In addition to the permission of the Sandusky Library, additional permissions may be required. Those permissions may include, but are not limited to:

Copyright: In cases of works by living artists and/or subject to the 1976 Copyright Law or the 1991 Visual Artists Rights Act, written permission must be secured by the applicant from the artist, his/her agent, or the copyright owner.

WARNING CONCERNING COPYRIGHT RESTRICTIONS

The Sandusky Library does not represent or warrant that the Library holds copyrights to the itemr to be reproduced nor that the Library has cleared all present and future uses with the copyright owner nor has the Library determined that items(s) for reproduction is/are otherwise encumbered. It is therefore the responsibility of the applicant to determine the copyright owner or the rights of any third parties and to clear any of the reproduction with such owner or third party.
